Methods and material for containment and cleaning up

Containment/Clean-up Measures

Avoid generating dust.

FOR SMALL SPILLS: Clean with a vacuum with a filtration system sufficient to remove and prevent recirculation of crystalline silica (a vacuum equipped with a high-efficiency particulate air (HEPA) filter is recommended).

FOR LARGE SPILLS: Use a fine spray or mist to control dust creation and carefully

scoop or shovel into clean dry container for later reuse or disposal.

If, an appropriate vacuum is unavailabe, only wet-clean-up methods should be used (i.e. misting). Moisture should be added as necessary to reduce exposure to airborne

respirable silica dust.

Section 7 - Handling and Storage

Precautions for safe handling

Handling

Do not breathe dust. Avoid contact with skin, eyes, and clothing. Minimize dust generation and accumulation. Use good safety and industrial hygiene practices. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Wear long sleeves and/or protective coveralls. Contaminated clothing must be vacuumed before removal. Engineering Measures/Controls

Good general ventilation should be used. Ventilation rates should be matched to conditions.
